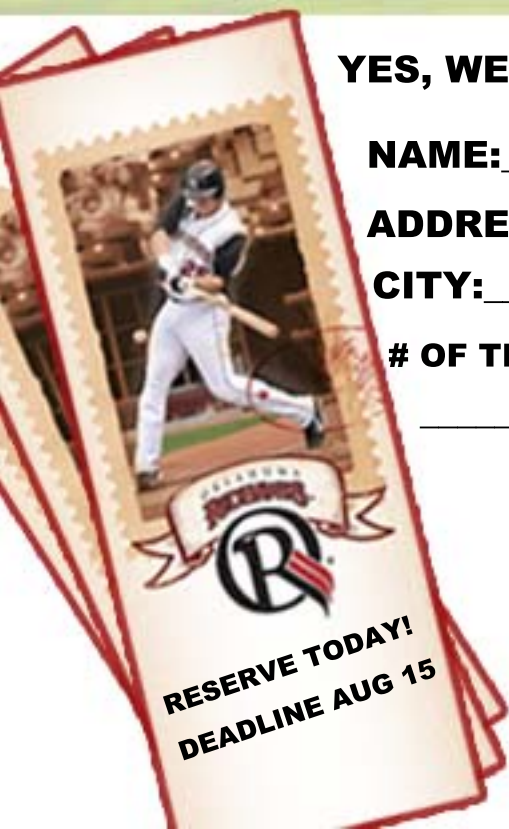

A late night snack is provided prior to the late movie. The following morning, rise and shine for a continental breakfast is at 7:00 a.m. and then Scouts pack out their gear. Departure time to leave The AT&T Bricktown Ballpark is at 8:00 a.m.

## **Guidelines for the Sleepover on August 23 are:**

30 minutes after the game, meet at the Warren Spahn Plaza entrance.

Parking is available in the Red Lot, located east of the ballpark

No chairs, cots, staked tents nor any items that could puncture the field.

No Outside food or drink will be permitted

The following areas are OFF LIMITS: The infield, dugouts, the stands, unless instructed by a Redhawks staff member, restrooms on the 3rd base side.

The Oklahoma RedHawks reserve the right to amend this list at any time prior to or during the sleepover. If any of the guidelines are not followed, you will be asked to leave the ballpark. NO EXCEPTIONS.
